1. BIOGRAPHICAL SUMMARY

James H. Stronge is the Heritage Professor of Education, a distinguished professorship, in the Educational Policy, Planning, and Leadership Area at the College of William and Mary, in Williamsburg, Virginia. He teaches doctoral courses within the School of Education's Educational Policy, Planning, and Leadership (EPPL) Program, with a particular focus on human resource leadership, legal issues in education, and applied research design. Stronge has garnered approximately \$34 million in grants and contracts since joining the faculty of the College of William and Mary, Additionally, he is CEO and President of Stronge and Associates Educational Consulting, LLC, an educational consulting company that focuses on teacher and leader effectiveness with projects internationally and in many U.S. states. Additionally, Dr. Stronge's research interests include policy and practice related to teacher quality and effectiveness, teacher and administrator evaluation, and teacher selection. He has worked with numerous state departments of education, school districts, and national and international educational organizations to design and implement evaluation and hiring systems for teachers, administrators, and support personnel. Recently, he completed work on new teacher and principal evaluation systems for American international schools in conjunction with the Association of American Schools in South America and supported by the U.S. Department of State. Stronge has made more than 400 presentations at regional, national, and international conferences, and conducted workshops for educational organizations extensively throughout the U.S. and internationally. Among his current research projects are: 1) international comparative studies of national award-winning teachers in the United States and China, and 2) influences of economic and societal trends on student academic performance in countries globally.

Stronge has authored, co-authored, or edited 32 books and approximately 200 articles, chapters, and technical reports. His recent books include: *Qualities of effective teachers* (3rd ed.) (2018, ASCD), *What makes a world class school and how to get there (2017, ASCD), West meets east: Best practices from expert teachers in the U.S. and China (2014, ASCD), Principal evaluation (2013, ASCD)*, and a series of books regarding teacher effectiveness published by Solution Tree Publishing: *Designing effective*

assessments (2016); Instructional strategies for effective teaching (2015); Instructional methods for differentiation & deeper learning (2015); and Effective planning for effective teaching (2015). His 1994 book, Educating Homeless Children and Adolescents: Evaluating Policy and Practice received the Outstanding Academic Book Award from the American Library Association.

Stronge was a founding member of the board of directors for the Consortium for Research on Educational Assessment and Teacher Effectiveness. In 2011, he was honored with the Frank E. Flora Lamp of Knowledge Award, presented by the Virginia Association of Secondary School Principals for "bringing honor to the profession" and his "record of outstanding contributions." He was selected as the 2012 national recipient of the Millman Award from CREATE in recognition of his work in the field of teacher and administrator evaluation.

Professional Consulting Services

Consulting services have been provided to approximately 500 national, state, and local organizations. The primary areas of emphasis include:

- 1) Performance evaluation for teachers, administrators, and educational specialists; Support schools, districts, and states in designing and developing comprehensive, uniform performance evaluation system that consists of parallel components for teachers, educational specialists, principals, central office administrators, and superintendents. Each educator receives a comprehensive performance portrait via evaluation on seven performance standards specific to the type of educator using multiple data sources, including observations, artifacts, optional surveys, and goal setting/student progress measures.
- 2) Teacher and principal effectiveness: Consulting services are designed to provide the latest research-to-practice tools and techniques related to the performance standards. Workshops provide a toolkit for teacher effectiveness in the areas of: professional knowledge, instructional planning, instructional delivery, assessment of/for learning, learning environment, professionalism, and student progress. Additional consulting services to support leaders and educational specialists are available.
- 3) Hiring the best teachers; Using the research on the most effective interviewing and selection strategies, the hiring protocol consists of a screening interview, comprehensive interview, performance component (for selected positions), reference check, and resulting professional development plan for teachers, paraprofessionals, educational specialists, principals, district leaders, classified personnel, and substitute teachers. Interview questions and scoring rubrics are aligned to the educators' evaluation system, enabling educators to be hired and evaluated based on the same set of criteria.
- 4) World-class schools: These keynote speeches and conference presentations re designed to guide school leaders to explore the attributes that explain or support the positive educational outcomes of selected countries whose students consistently rank high on international assessments. The research focuses on assisting leaders in developing a deeper understanding that globalization and technology are rapidly reshaping the world and transforming the demand for talent. The presentations also are intended to enhance awareness about preparing students for the 21st century. Participants explore what qualities a world-class school should have, the lessons learned from top-performing countries with regards to educational policy and practice, and how to apply those qualities and lessons to their current school or district.
